Dear Massage School Applicant,

Enclosed is everything you need to register for our 800 Hour Massage Therapy Program. **We are the school of choice in Alaska for Oriental Healing Massage and Bodywork**, and you will see that we are much more than just a Massage School – we are a healing journey. Our school places a very high emphasis on ensuring that you are successful in this field. After you graduate and become a Licensed Massage Therapist, we have several work opportunities available to those interested through The Oriental Healing Arts Center and Massage Now!. We also offer a full line of Advanced Massage Therapy and Oriental Medicine courses to further benefit your career, including programs in TuiNa Acupressure Massage (Chinese), Energy Medicine Healing (Taoist), Chinese Herbs, 5-Element Nutrition, Essential Oil Certification, and more.

How the program works:

- We offer 2 schedules to fit various time and financial needs. Full Time Program D is approved for financial aid through Alaska State Student Loans. Part Time Program C is not eligible for financial aid through Alaska State Student Loans, however this program may qualify for other types of financial aid. Please check with your provider to determine eligibility.

Program D1: 800 Hour Massage Therapy Program: Mon, Wed, Fri 9:30am-3:00pm (10 months)
800 Hour Thai Yoga Massage Program: Mon-Thur, 6:00-9:00pm (12 months)

Program C: Both programs - take up to 3 years to complete all classes

- **Program D1: This program is eligible for GI Bill and Alaska State Student Loans.** It is the shortest time period, 10 months for our traditional Massage Therapy Program or 12 months for our Thai Yoga Massage program. Students should be ready to apply a time commitment during non-class hours to complete the required student clinic hours.
- **Program C:** If a flexible schedule best suits your needs this program is for you. Remember that it is not eligible for Alaska State Student Loans, however it may be eligible for other types of funding. We recommend starting with Anatomy as your first class, and if you can take more add on Physiology and Chair Massage. Classes are offered twice each year – Spring and Fall – and you have 3 years to finish all 800 hours.
 - You must take the Anatomy course in order to take any hands-on massage classes so we recommend that you take Anatomy first, or at the same time as a hands-on massage class. It is important to know the muscles and bones you are touching when doing massage.

How to Apply and Register:

1. One of our Recruitment Officers will guide you completely through the registration process, including the application kit, financial aid assistance, and orientation. If you need a Recruitment Officer to work with, contact us at 907-279-0135.
2. The earlier you apply for financial aid the better. Some agencies will not approve funding if you are already attending classes that have started.
3. Payment:
 - Enclose payment for your course tuition. Acceptable forms are cash, check (payable to AKInstitute) or MC/Visa/Discover/AMEX.
 - If you have requested our internal payment plan you must put at least 25% down. Your Admissions Officer will assist you with a Payment Plan Agreement which must be completed and signed.
 - If you have applied for or will be receiving financial aid write in the name of the agency which will be funding your tuition and the total amount.
4. The Massage Therapy Program Director will review your application after which you will receive a letter of acceptance, acceptance pending specific items, or denial to the program.

Massage Therapy Program applicants must be aware of the licensing requirements for the State of Alaska in order to work in the field of massage therapy after graduation. If there are any requirements, particularly in the area of crimes and convictions that are of concern to be a barrier in becoming licensed, your application to our program will only be approved if we deem that you are a successful candidate to pursue licensing, or you acknowledge that you are aware you may not be approved for a license in the State of Alaska and you wish to apply for reasons other than becoming licensed.

MESSAGE THERAPY LICENSING REQUIREMENTS FOR THE STATE OF ALASKA

- Completion of a course of study of at least 500 hours of in-class supervised instruction and clinical work from a board-approved massage school.
AND
Verification of having passed the MBLEX national exam (NOTE: The MBLEX exam is only available in written English and Spanish. Interpreters are not allowed. It can be taken by students towards the end of our program or after graduation.)
- Have been fingerprinted and passed a national criminal history record check. (We will go through this process together during our Business Practices class.)
- Have a current CPR certification and completion of at least 4 hours of safety education in bloodborne pathogens and universal precautions. (NOTE: This training is offered through our school via an outside approved agency. The cost of approximately \$90-\$115 is not included in tuition. Applicants may opt to take training from any approved agency of their choice.)
- Has not been convicted of, or pled guilty or no contest to, a crime involving moral turpitude, or who has been convicted of, or pled guilty or no contest to, a crime involving moral turpitude if the board finds that the conviction does not affect the applicant's ability to practice competently and safely. The State of Alaska Massage Therapy Board's definition of moral turpitude is:
 - (1) homicide;
 - (2) manslaughter;
 - (3) assault
 - (4) stalking;
 - (5) kidnapping;
 - (6) sexual assault;
 - (7) sexual abuse of a minor;
 - (8) unlawful exploitation of a minor, including possession or distribution of child pornography;
 - (9) indecent exposure;
 - (10) unlawful distribution or possession for distribution of a controlled substance;
 - (11) prostitution;

(12) sex trafficking

Questions on the State of Alaska Application for Massage Therapy License you must answer: The following questions must be answered. “Yes” answers may not automatically result in license denial. If you answer “Yes” to any of the questions, you will be asked to explain dates and circumstances on a separate piece of paper, signed and dated, and send any supporting documents that are applicable (court records, judgments, charging documents, etc.) to the Massage Therapy Board attached to your license application. Applications submitted without the appropriate attachments will be considered incomplete and will not be processed.

1. Have you been convicted of a crime or are you currently charged with committing a crime? For purposes of this question, “crime” includes a misdemeanor, felony, or a military offense, including a conviction involving driving under the influence (DUI) or driving while intoxicated (DWI), driving without a license, reckless driving, or driving with a suspended or revoked license. “Convicted” includes having been found guilty by verdict of a judge or jury, having entered a plea of guilty, nolo contendere or no contest, or having been given probation, a suspended imposition of sentence, or a fine.

PAYMENT OF CHILD SUPPORT AND STUDENT LOANS, to be aware of in order to maintain a viable Massage Therapy license:

If the Alaska Child Support Enforcement Division has determined that you are in arrears on child support, or if the Alaska Commission on Postsecondary Education has determined you are in loan default, you may be issued a nonrenewable temporary license valid for 150 days. Contact Child Support Services at (907) 269-6900 or the Postsecondary Education office at (907) 465-2962 or 1-800-441-2962 to resolve payment issues.
